

BOARDING CONTRACT

TERMS

1. PAYMENT - OWNER will pay SDQH in monthly payments of \$600.00 per month from the date the HORSE is delivered to the SDQH facility and at the beginning of each subsequent month. If OWNER chooses premium feed; monthly payments will be \$625.00 per month. Each horse must use \$100 in lessons or training fees per month. If this quota is not met, the owner is required to pay the remaining balance at the end of each month.

2. ADDITIONAL EXPENSES - OWNER will be responsible for all veterinary expenses, farrier expenses, de-worming, vaccinations, feed supplements, entry fees, stabling at competitions, transportation costs, schooling at facilities (other than SDQH), and necessary hotel accommodations associated with the HORSE. See Appendix for list of additional costs where services are provided.

a. Resident horses at SDQH are de-wormed according to need after fecal floatation results. Horses at the facility for short-term training MUST be dewormed prior to arrival. The OWNER is responsible for testing and deworming of the HORSE. Horses staying for prolonged periods at SDQH will be included in SDQH's parasite control program.

b. All horses entering the facility must have current vaccinations and Coggins certificates. These must be provided at the time of arrival of the HORSE at SDQH.

3. CARE - SDQH will provide feed in the amount of 6 lbs. of grain, four flakes of hay (2 AM/2 PM), water, a stall, and daily turnout in the paddock (weather permitting) of her choosing. OWNER has examined the facility and understands and accepts inherent risks involved in turnout and stabling at this facility.

4. RISKS - Neither SDQH, nor any persons associated with this party shall be liable for any sickness, disease, theft, injury, or death suffered by the HORSE or any cause of action arising from or connected to boarding or training of this HORSE. All risks are assumed by the OWNER.

5. EMERGENCY CARE - If medical treatment is needed for the HORSE, Scioto Darby Quarter Horses or its agents will attempt to contact OWNER, but in the event that OWNER is not reached, SDQH or its agents have the authority to secure veterinary or farrier care, the cost of which will be borne by OWNER.
6. COMMISSION - A sales commission of 10% of the sale price will be assessed for any HORSE sold by Scioto Darby Quarter Horses.
7. TERMINATION - Both parties can opt to have the boarding end and the HORSE removed from SDQH at any time. In this case, SDQH will not refund OWNER for any prepaid board that will not be provided.
8. NOTICE - Owner agrees to give Scioto Darby Quarter Horses thirty (30) days' notice, in writing, to terminate this agreement. The Owner cannot assign this agreement unless Scioto Darby Quarter Horses agrees in writing.
9. RIGHT OF LIEN - Scioto Darby Quarter Horses has the right of lien as set forth in the law of the State of Ohio for the amount due for board and/or training and additional agreed upon services and shall have the right, without process of law, to retain said HORSE until the indebtedness is satisfactorily paid in full. During the time that a past due balance is owed, daily permission must be granted to enter SDQH property.
